

Ripped From the Headlines: Embezzlement Could Happen to You

The Federal Bureau of Investigation (FBI) defines embezzlement as the "misappropriation or misapplication of money or property entrusted to one's care, custody, or control." What distinguishes embezzlement from other types of theft is the violation of financial trust between the owner of the money or property and the offender.

What to watch for:

- Missing cash
- Unexplained inventory losses
- Higher than normal expense accounts
- · Invalid billings
- · Increased hours on time sheets
- Responsibility for deposits, check writing and signing, and checkbook reconciliation with the same person
- Financial statements with gaps or unexplained inconsistencies
- Bookkeepers or financial staff who are always late with reports
- Unexplained petty cash expenditures
- Inconsistent and unexplainable behavior relative to any financial matters

The former chief financial officer of an Orange County technology company was sentenced to more than four years in federal prison for stealing about \$15 million from the company. Jean Joseph Ibrahim pleaded guilty in 2012 to a charge related to the embezzlement from his analyser, Trustin Technology, which worked with companies such as

Inc. and IBM. He was sentenced Wednesday to 50 months in prison rdered to repay the company.
