Trump paid attention to the message from white working class workers that he needed to "Drain the Swamp" in Washington

- Illegal immigration cannot continue – impacts jobs
- The polls got it all wrong they polled the wrong people and did not get enough of a crosssection of America
- The media did not appreciate or understand the anger and angst of the white working class
- The working class was fighting the educated, elite establishment and did not care that Trump ran a rough campaign. They wanted an outsider.
- The working class has not benefitted from changes in the past decade and they don't like the cultural changes that have occurred. They feel they are living in "a strange land."
